Note : Maximum concession under Sports/Games/NCC / Scout / Guide/Adventure will not exceed 06% Marks in aggregate .In case of eligibility for more than one concession under different categories as mentioned at (a) and (b) above, only one concession having maximum advantage to the candidate will be allowed (The same benefit may be extended to non-KV Students for fresh admission in KVs.)
